With a very holistic approach, SiA works very closely with local communities to develop and implement socially, culturally and economically appropriate services. The entire program is based on demystifying and transferring technology in simple and relevant terms at the community level.

SiA is the member of Central Advisory Board for Disabilities (CABD) MSJEGOI which is responsible for advising the central government in implementing RPD in the year 2016. SiA has been on various committees of the Centra land State Government to develop policies and training programs. Seva-in-Action has also bagged many awards for its services in inclusive education and community-based rehabilitation from the Government of India and the State Government.

# ENABLING AND EMPOWERING PERSONS WITH INTELLECTUAL & DEVELOPMENTAL DISABILITIES TOWARDS SELF INDEPENDENCE. HIGHLIGHTS

#### 1. CULTIVATING A CONSCIOUS MIND THROUGH ART & YOGA!

Working in the disability sector for more than two decades and emphasizing Inclusion as the need of the hour, we at Seva in Action, have always been keen on organizing inclusive events. This year, on the occasion of International Day of Yoga a one-week camp, supported by the Multinational Corporation PayPal (in collaboration with Zuria, a Not-for-Profit organization) was organized.

50+ students with diverse abilities and Employees of PayPal accessed the online space creating an Inclusive Environment.

Well-crafted virtual sessions were effective in helping students achieve a balanced state of mind, physical benefits for candidates with cerebral palsy and being an enjoyable experience on the whole. Self-reflection and personality development were combined to be a part of the session.



#### 2. LEARNING THE MIGHTY MANTRA OF MANDALA ART THROUGH AN INTERFACE!

One of the objectives at SiA is to provide exposure to concepts and stimulate engagement in our trainees. Training programs that can be intertwined with life skills are conducted periodically. The Mandala Art Training Program is organized with the objective of skilling students in art and most importantly create an outlet to display their inherent creativity. The sessions are conducted virtually by a resource person from the U.S.A. The colorful wheels enable students to express themselves in a vibrant yet calm manner and has yielded therapeutic results and improvements in concentration, meditation and positive behavioural changes.

#### Feedback from a parent:

"Earlier Mr. Namish would run around frantically every 10-15 minutes, after attending the Online Mandala art training program, he is now able to sit and work continuously for 2 to 3 hours"



#### 3. A PATRIOTIC CELEBRATION- '75<sup>TH</sup> INDEPENDENCE DAY'!

We are always motivated to organize activities to ensure our beneficiaries are equipped with skills that they use on a daily basis. A Flag Making Workshop was conducted virtually on 15<sup>th</sup> August on the occasion of Independence Day.

The program also included a performance of the song 'Vande Mataram' by a professional singer. The singing activity acted as a great opportunity for vocal exercising for the students.

# 4. ENRICHMENT PROGRAM: FIRST AID TRAINING- LEARNING LIFE-SAVING SKILLS!

The significant impact of imparting practical life skills to children and adults with diverse



abilities is renowned and acknowledged widely. It is aimed at preparing them to function as independently as possible and also strengthen their abilities and capabilities. Seva-in-Action organized a First-Aid Training Session for both Students & Parents.

With an objective to equip students with some amount of basic knowledge and instructions to handle critical situations, they were trained on

effectively. A pictorial PowerPoint presentation clearly demonstrated some relatively simple techniques and procedures to be carried out for the victim of injury or illness. The program also aimed at instilling confidence amongst students and their families aiming for a secure and safer environment.

# **5.ACCELERATING THE COVID-19 VACCINATION DRIVE: #Protect Yourself** #Protect Others #Get Immunized

Seva-in-Action in association with Bruhat Bengaluru MahanagaraPalike (BBMP) organized a vaccination drive on 26<sup>th</sup> May 2021, coordinated by Disability NGOs Alliance (DNA). During the drive, 140 plus people with disabilities were vaccinated free of cost, including their family members. The drive was organized around the time when there was an acute shortage of vaccines and vaccines were unaffordable for common people and it was efficiently conducted following all guidelines by the Government.

Continuity in gaining skills during the online mode of learning has been one of the focus areas of all our services and is of utmost importance. We have made it a priority to foster development and growth by working on an individual basis. By providing necessary training, we work to accommodate each individual's specific needs, enhancing their skill sets.

#### 11. INCLUSION THROUGH WORK AND LIVELIHOOD!

Having access to Equal Employment Opportunities for individuals with disabilities is the one of the most integral part of our mission at Seva-in-Action. We saw our training come to fruition when three trainees from SiA got employed in a Multinational Corporation "Wells Fargo", Bengaluru, permanently from March 2022 onward. Previously, they were trained for four months of employability skill development and had the opportunity to undergo three months of paid internship in the company, virtually. Their placement raises hope for equitable job opportunities for PWIDDs.

We believe that Advocacy for children/adults with disabilities is vitally important and it instils in them the confidence to build happy and successful lives in whichever way possible. In the spirit of bringing about social-awareness and emphasizing the rights of the differently abled, the 6<sup>th</sup> National Convention of Self Advocacy Forum of India (SAFI) was held at Yuvakshetra Institute of Management, Palakkad, Kerala on the 7<sup>th</sup> and 8<sup>th</sup> May 2022. From Karnataka, the convention saw the participation of nine self-advocates along with 3 mentors. Mr. Abhishek, the Joint Secretary of SAFI presented the annual report.

With partial lockdowns and strict guidelines from the Government, Team Seva-in-Action, complied with all the necessary protocols. Our festive celebrations were held virtually in a complete safe space with unlimited interaction and fun. #### 16. CSR ACTIVITIES:

At Seva-in-Action, we make use of every opportunity presented to 'Push for Inclusion'. We prioritize and encourage interaction with Employees and Staff from the working sector. We believe that this exposure is crucial. While these interactions help our beneficiaries to participate in work-based learning experiences, it also an opportunity to remove stigmas and encourage social integration.

This year, we had a numerous companies visiting Seva-in-Action and interacting with our team. The Production Unit of Seva-in-Action – RACHANA, showcases numerous handmade products made by our beneficiaries and these are retailed to the Corporates and to any person who are interested to buy them.





### **INCLUSIVE EDUCATION**

Our commitment to prioritize "Inclusive Education" as a Long-Term Solution to bring about genuine changes for Children and Persons with Disabilities has been "Action in Progress" all along. While, Seva-in-Action emphasizes on promoting "Inclusion" as a mind-set we also have committed ourselves to ensure that we accomplish this through "Education".

By advocating in a variety of ways through – Training, working with Teachers, helping schools adopt an Inclusive Curriculum and finally by working directly with the Government, we strive towards making Inclusive Education a reality. Create a Society where we can change mindsets and help children/adults of diverse abilities to lead a normal life.

Endorsing collaborations with Teacher Communities in Schools, Colleges and Research centres is extremely crucial from an Inclusive perspective. We, at Seva-in-Action look at it as a pathway to make and grow stronger teacher communities to promote integration. Our staff and members of the Management team have been constantly involved in revitalising and stimulating Research works and Projects, directly related to Inclusive Education.

From being involved in Research, designing/reframing curriculums in the grassroots levels of the Government systems, to collaborations with like-minded Organisations, we have welcomed opportunities for Professional Learning and Growth.

Our contribution towards Research and Development (Inclusive Education) are as follows:

#### **RESEARCH PROJECTS:**

Ruma Banerjee, Vice-Chair Person, Seva-in-Action was a consultant to the Clear Learning and Research (CLearR) on Inclusive Education, a project of TISS in collaboration with Cognizant Foundation.

#### AIM:

The aim of this research project was to ensure a more sustainable means of contributing to the knowledge and practice of Inclusive Education, with a special focus on the 'Education of Children with Disabilities'. The study was intended to go beyond ascertaining challenges and bottle-necks in teacher preparation and focus on specific areas and needs to inform teacher education, both at the systemic level and in the classroom contexts.

#### **OBJECTIVES**

- To develop Competency framework for preservice teacher education through desk review of different courses across the globe.
- To study the curriculum of pre-service teacher education programs being offered by NCTE and RCI vis-à-vis inclusive education, in terms of developing competencies for implementing IE.
- To assess the gaps in competencies required for human resource development and identify areas of priority for professional development.

#### **HIGHLIGHTS:**

Ruma Banerjee was also the Resource Person for the 6-week Postgraduate certificate course for practicing teachers, principal's educationist and special educators conducted under CLearR on Tissx online platform by TISS.

The purpose of this training was to equip teachers with innovative ideas for developing inclusive classroom practices.

## WORKING WITH THE GOVERNMENT SYSTEMS: HIGH LIGHTS:

Ruma Banerjee was attended the executive council meeting and general council meetings of RCI to provide with suggestions for the revised training program in different disabilities.

#### AIM:

To provide with necessary suggestions to improve the quality of training programs and establish effective regulatory and monitoring systems by RCI for effective implementation of training programs by various organizations and institutions.



Manjula Nanjundaiah was invited as a Resource person to conduct two sessions on a three-day training program organised by Samagra Shikshana-Karnataka. The first day session was on "An Introduction to IE & 21 types of disabilities and the second day session was on UDL Strategies." This was a part of the State level capacity building of BIERTs from 34 Educational

Districts of Karnataka in 3 days' MRP training on inclusive Education (IE) held from 16th-18th November 2021 at Indian Social Institute, Bengaluru by Samagra Shikshana Karnataka, GOK.

#### **CONTRIBUTION TOWARDS NEP 2020**

As part of NEP implementation, the Ministry of Education has initiated work on creating National and State Curriculum Frameworks for school education. In this regard, NCERT has identified around 25 topics for preparation of position papers which guide the NCFs and SCFs in different subjects. Inclusive Education was also selected as an important topic.

#### **HIGHLIGHTS:**

Manjula Nanjundaiah was invited by Vidya Bharati and Shikshana Sankula (Organisations workings in the field of Inclusive Education) for her comments from the perspective of NEP 2020, highlighting the issues in the state of Karnataka. She suggested strategies to bring reforms in the system which guide position papers for the State of Karnataka.



A write up of 2000 words on IE from the perspective of NEP 2020 as per their request was submitted by her.

Ms. Manjula Nanjundaiah from SiA as a Working committee member of the IE Position Paper presented the group discussion points in the presence of the State Education Minister and committed to abide by 15<sup>th</sup> December 2021 deadline to submit our 1<sup>st</sup> draft of position paper on behalf of our group as the Minister urged every group

#### SKILL DEVELOPMENT TRAINING & LIVELIHOOD OPPORTUNITIES' UNIT AT SIA

The Skill Development and Livelihood Program was initiated with an aim to enhance employability skills for adolescents & young adults with Intellectual & Developmental Disabilities and increase employability skills.

The main target is to boost their potentials which would eventually assist them in obtaining gainful employment and also help having access to meaningful livelihood opportunities.

**VIKAAS CENTRE** –The center aims at providing Pre-vocational & Vocational training to Adults with intellectual & developmental disabilities(AWIDDs) under the Vikaas Day Care Scheme.


#### SOCIAL CATALYST FUNDS FROM LTI FOR UPGRADING TRAINING CENTERS:

### PROFESSIONAL DEVELOPMENT INCLUSIVE EDUCATION(IE)



The event is designed to include five different categories of disability namely: *Intellectual Disability (ID)*, *Cerebral Palsy (CP)*, *Autism Spectrum Disorder (ASD)*, *Visual Impairment (VI)*, & *Hearing Impairment (HI)*.



### FOCUS ON RESEARCH AND DEVELOPMENT IMPACT ASSESSMENT – QUIZABLED

It aims to enable quality education for all children in India -through professional development of teachers and create an impact in the education space. The purpose of the assessment was to understand how the platform 'Quizabled' has enabled knowledge development of children with disabilities through quizzing and raised awareness regarding valuing diversities in the society.

PARAMETERS: Equality of opportunities, Non-Discrimination, Awareness Raising and Inclusion

#### **OBJECTIVES**:

To assess the impact of learning and socialization through quizzing in children across disabilities from rural and urban areas, special schools, inclusive & residential schools of Karnataka (6 districts) Tamil Nadu (6 districts) and Mumbai.

Experience of teachers and parents towards children and youths with disabilities.

Impact on schools due to children participating in Quizabled

Changes in attitude among LTI volunteers towards children with disabilities
